- 1. Approves the proposed fee schedule, which reflects changes to fees for FY2026
- 2. Authorizes the implementation of the fees effective October 1st, 2025
- 3. Directs staff to provide appropriate notice to all affected stakeholders and to publish the revised fee schedule on the City's website

Policy Change Proposal: Restricted Golf Pass Time Adjustment

To: Golf Club Members and Passholders

Subject: Adjustment to Restricted Golf Pass Tee Time Availability

Background

The Restricted Golf Pass was initially created to provide flexible and affordable course access during lower-demand hours. Under the current policy, restricted passholders may book tee times from 6:00 AM to 8:00 AM and again from 12:00 PM onward on Weekends and holidays, helping manage course traffic while offering value to our members.

Proposed Change

Effective 2/1/2026 the morning access window (6:00 AM – 8:00 AM weekend and Holiday) will be discontinued. Moving forward, Restricted Golf Pass holders will be permitted to book tee times strictly from 12:00 PM on Weekends and Holidays onward.

Rationale for Change

- Course Access Equity: Early morning tee times have become increasingly in demand among full membership categories. Removing the 6:00–8:00 AM access for restricted passes ensures these high-demand hours remain available to full-paying members.
- Operational Efficiency: Morning tee times often set the pace for the rest of the day.
 Consolidating early access to full members helps maintain consistent flow and pace-of-play standards.
- Program Integrity: The Restricted Golf Pass is designed around off-peak access.
 Reinforcing the restriction aligns the policy more closely with its intended purpose and pricing model.

Member Impact

We recognize this change may affect routines for some passholders. If you fall into this category, then we recommend that you consider upgrading to the unrestricted pass. Restricted passholders may still play during these windows but will incur a greens fee when they check in prior to noon on Weekends and Holidays at the shop.

This adjustment supports the long-term sustainability of our tee sheet, maintains fairness among membership tiers, and helps improve the overall member experience. We appreciate your understanding and continued support.
