RV PARK GUIDELINES

- Parking is limited to the asphalt/gravel areas only; no parking on the grass or streets (all roads are fire lanes.)
- SPEED LIMIT IS 5 MPH! Please ensure the safety for foot traffic and children.
- Please respect fellow guests; No walking or driving through other sites, occupied or not. No loud music of any kind at any time. QUIET HOURS are between 11:00 PM and 7:00 AM.
- Tents and temporary shelters are not allowed in the park.
- Caution: No stakes or tie downs in grass areas. No digging whatsoever, and please ask approval from CEC Superintendent prior to driving any stakes in the gravel.
- Threaded/sealed connections are required for sewer hookups.
- Pets are welcome, if well behaved. All pets must be on a short leash at all times (electronic leashes are not allowed within the RV Park.) Pet poop must be scooped IMMEDIATELY! Please do not leave pets tied up and unattended outside your RV. Owners are responsible for damage caused by pets.
- Please help protect our trees. No clotheslines tied to them, or items put on the grass that may damage it. Our landscape areas and mounds are not bike ramps or toys for children.
- Trash receptacles are onsite, please ensure you get your garbage inside the receptacle.
- CAMP FIRES: **No ground or wood fires permitted.** We do allow charcoal/propane fire pits and barbeques.
- Our grass is watered from 12:00 AM 6:00 AM. Items left on the grass may get wet.
- Children under the age of 14 must be under direct adult supervision at all times.
- Checkout time is 11:00 AM
- No refunds will be given.
- Each site is for one (1) RV.
