2. I, the Property Owner, acknowledge that I have been advised, and agree, that I will remain responsible and liable for any unpaid account balances for all City services assessed against the residential premises listed in Exhibit "A" that exceeds the deposit of \$100.
I have been advised that a new tenants name will not be added until all delinquent accounts are paid in full.
3. I also relinquish my authority to terminate services to the property while occupied by the tenant except when the tenant's account is delinquent or amount owing exceeds the deposit.
