The City of Caldwell and Girl's Athletic League Softball, Inc. ("G.A.L.S.") of Caldwell have had a long and mutually beneficial relationship dating back to 2002. That relationship is centered on the use and operation of the quad-softball complex at Pipe Dream Park. Both Caldwell and G.A.L.S. look forward to continuing this relationship for many years to come.

During the past several months a dispute developed between Caldwell and G.A.L.S. over responsibility for payment of a contractor's bill that was incurred in connection with the installation of field lighting at the quad; each party looking to the other to pay the bill. A compromise has been reached. Although G.A.L.S. and some of its supporters expressed public frustration with Caldwell over the matter, G.A.L.S.' leadership acknowledges that Caldwell had good and fair reasons to dispute responsibility for the invoice and appreciates Caldwell's willingness to help G.A.L.S. fund a solution. Both parties look forward to putting this issue behind them and continuing their partnership to serve the youth of our community.
