
Re: Election finance

I am writing to inform you of a discrepancy in my financial reports. On December 12, 2018, I moved my campaign monies (\$577.58) from DL Evans Bank to Pioneer Federal Credit Union.

Approximately two months after the move I realized that Pioneer Federal was subtracting monthly fees from my new account. I immediately stopped the fees however there is now a difference of \$3.98 between what I last reported and my current statement. The credit union subtracted \$1.99 per month in fees for two months. This happened during a non-election period.
