

Questions and Answers

- **Will a new license be required every year for my dog?**

A yearly renewal of the dog license is required unless the owner opts to purchase the three-year dog license.

If the canine was previously licensed through Canyon County, upon expiration, please renew the license through the City of Caldwell.

Note: Dogs under one year of age are only eligible for a one-year dog license.

- **What if my dog is deceased or I no longer own the animal which license is up for renewal?**

If your dog is deceased, please inform City Hall as to the date of death. If you no longer own the animal, please e-mail the City of Caldwell at petlicense@ci.caldwell.id.us or call 455-3000 about this change. The license may be transferred for a minimal fee as listed on the fee schedule.

NOTE: No refunds will be issued for dog licenses.

- **Does the City of Caldwell have a leash law?**

Yes, the Caldwell City Code (Section 08-03-17) states that it is unlawful for a dog owner to permit the animal to run "at large." Therefore, when an animal is off the owner's premises, a leash must be used.

- **Are dogs allowed in the City parks?**

Dogs are allowed within City of Caldwell parks providing that they are kept on a leash. Also, please be considerate of others using the parks and pick up your animal's waste as necessary.

Process to acquire a Caldwell Dog License:

Option #1:

Complete the application printed on this brochure and either deliver or mail the form with your payment to Caldwell City Hall at P.O. Box 1179, 411 Blaine Street, Caldwell, ID 83606.

Option #2:

Contact a local veterinarian clinic as listed on this brochure to obtain the license.

NOTE: Proof of rabies and if the dog has been altered (spayed/neutered) must be provided at the time of application submittal.

KENNEL LICENSE (City Code Section 8-3-09)
1. It shall be unlawful for any person to own, harbor, keep or possess a canine more than six (6) months of a age within the city without first procuring a license.
2. It is prohibited to own, harbor, keep or possess more than three (3) dogs on any residential premises within the city limits.
3. Kennel licenses are required for all kennels. Kennels may have more than three (3) dogs. However, kennels are prohibited in any residential area. Therefore, if you live in a residential area, you are prohibited from having more than three (3) dogs.
