\_\_\_ When due to physical health or ability, the operation of the gravity irrigation system has become too difficult to manage, a written letter explaining the hardship case shall be attached to the application for

consideration. Hardship cases are mutually approved on a case by case basis by the public works director/city engineer and water department.

**2. Owner, Developer and Engineer please initial the following statements indicating that they have been read and understood and that they will be complied with exactly:**

- \_\_\_\_\_ Applications are approved or denied on a case-by-case basis by the City Engineer.
- \_\_\_\_\_ If a property is reliant upon City water for irrigation purposes and opportunity becomes available to connect to a pressurized irrigation system, that connection shall take place.
- \_\_\_\_\_ In the event the above statement occurs, lock out devices approved by the City shall be installed to ensure that City water is no longer used during the irrigation season.
- \_\_\_\_\_ Any connection to the potable water system for irrigation shall be made in compliance with City and Caldwell Municipal Irrigation District standards including the use of an approved backflow prevention device and must be approved by the City Engineer.
- \_\_\_\_\_ Design of the irrigation system shall follow the requirements of Caldwell Municipal Irrigation District.
