

**GENERAL INFORMATION FOR PRESSURIZED IRRIGATION SYSTEM
AND
CALDWELL MUNICIPAL IRRIGATION DISTRICT'S ROLE**

***ATTENTION*: Caldwell Municipal Irrigation District is implementing an odd and even watering day schedule. If your house address ends in an odd number please water only on odd number days. If it ends in an even number please water only on even number days. It is very important that Common lots follow this schedule as well. Your cooperation in this matter is greatly appreciated.**

FOR SAFETY'S SAKE:

→ The water provided is for **Irrigation Use Only! Under no circumstances should the irrigation water be used as drinking water!**

FOR MAINTENANCE OR LINE BREAKS:

→ Call (208)455-3070 week days from 8:00am to 5:00pm concerning items such as pressure, leaks and design specifications.

→ Call (208)250-1638 after hours 5:00pm to 8:00am, and on weekends concerning items such as leaks and pressure problems.

FOR LINE LOCATIONS OF BURIED IRRIGATION MAIN LINES:

→ Call Dig Line at (208)342-1585. Call at least **2 working days before you dig...**

IF YOU DO NOT CALL, YOU ARE RESPONSIBLE FOR ANY AND ALL DAMAGES!

GENERAL INFORMATION:

→ Pressurized irrigation water is delivered between 40-60 pounds per square inch. Home sprinkler systems should be designed not to exceed 10 gallons per minute per watering station.

→ Caldwell Municipal Irrigation District will perform all repairs to the main system, and the cost of those repairs will be included in the assessments for operation and maintenance of the pressurized irrigation system. Individual landowners will be responsible from the shut off valve in their yard, and their own sprinkler system such as lawn and garden sprinklers, as well as the winterizing of their private sprinkler systems.

→ **Depending upon availability of water,** systems will be **turned on approximately April 15th,** and will be shut down between **October 1st & 15th** of each season.

****WINTERIZATION**:**

→ **When blowing out your sprinkler lines in the Fall,** please make sure that the Caldwell Municipal Irrigation valve in the white pipe is left **ON,** after your winterization company is done blowing out the sprinkler lines. This will allow you to receive your irrigation water in the Spring as soon as the pump stations are charged and available for usage. CMID is not responsible to go out to your property to turn on our valve in the white pipe if your winterization company shut it off in the Fall. It should be ON at all times. There will be a **\$15.00** turn on fee from CMID if you request CMID to turn it on.

Attention:

- **Caldwell Municipal Irrigation will bill out charges prior to water use, per Idaho Code Title 50 chapter 18.**
- **A bill will average around \$127.05 this year, for a property sized 10,000 sq ft and under.**
- **An irrigation bill is based on the sq ft size of property.**

***** A Board of Corrections** will be available at the City of Caldwell Water Dept. located at 305 W. Chicago St., March 14th – 16th between 8:00am – 5:00pm, if you need to up date any corrections on the irrigation bill.
